Name of the Scheme

Clarity Funds Scheme (**Scheme**). The Scheme comprises the following eight retail funds:

- Clarity Trans-Tasman Value Fund (previously "Clarity Trans-Tasman Fund")
- Clarity Dividend Yield Fund
- Clarity Fixed Income Fund
- Clarity Global Shares Fund
- Clarity Diversified Income Fund
- Clarity Diversified Growth Fund
- Clarity - Capital Group New Perspective Fund
- Clarity New Zealand Equity Fund

(each a **Fund** and together the **Funds** or **Clarity Funds**).

Type of Scheme

The Scheme is a registered Managed Investment Scheme which is an "other" managed fund, that is, a managed fund that is not a KiwiSaver scheme, workplace savings scheme or superannuation scheme.

Changes relating to the Scheme

During the Accounting Period the following material changes have been made to the Scheme, the Statement of Investment Policy and Objectives (SIPO), and the management of the Scheme.

The Scheme introduced two new retail fund offerings, being the Clarity New Zealand Equity Fund and Clarity - Capital Group New Perspective Fund, both effective 25 October 2019. In late October 2019, the Scheme reduced the annual fund charges for the Clarity Fixed Income Fund and Clarity Diversified Income Fund. The Clarity Trans-Tasman Value Fund commenced quarterly distributions from November 2019.

Some changes were made to the market benchmarks for the Clarity Dividend Yield Fund, Clarity Diversified Income Fund, Clarity Trans-Tasman Value Fund and Clarity Diversified Growth Fund, effective 25 October 2019. The SIPO was updated to recognise these changes.

Since the end of the Accounting Period, further changes were made to single security limit and range limits for the Clarity New Zealand Equity Fund.

No related party transactions were entered into during the Accounting Period that were not at arm's-length and enacted on normal commercial terms.
