Details of the scheme

The name of the Scheme is Clarity Funds Scheme, comprising nine retail funds:

- Clarity Trans-Tasman Value Fund
- Clarity Dividend Yield Fund
- Clarity Fixed Income Fund
- Clarity Global Shares Fund
- Clarity Diversified Income Fund
- Clarity Diversified Growth Fund
- Clarity Capital Group New Perspective Fund
- Clarity New Zealand Equity Fund
- TAHITO Te Tai o Rehua Fund

The Scheme is a registered Managed Investment Scheme which is an "other" managed fund, that is, a managed fund that is not a KiwiSaver scheme, workplace savings scheme or superannuation scheme.

The Manager of the Scheme is Clarity Funds Management Limited (Clarity).

The Supervisor of the Scheme is New Zealand Guardian Trust Company Limited (Guardian Trust).

The latest Product Disclosure Statements are dated 30 September 2022 for the Clarity Funds and 27 July 2023 for the TAHITO Te Tai o Rehua Fund, both are open for applications.

The latest Fund Updates for each of the funds in the Scheme are for the quarter ended 30 June 2023 and were made publicly available on 31 July 2023. Copies of these can be found at www.clarityfunds.co.nz or on the offer register www.business.govt.nz/disclose.

The latest financial statements and auditor's reports for the Scheme for the period ended 31 March 2023 (the Accounting Period) have been lodged with the Registrar. The auditor's report did not contain any materially adverse findings nor was it qualified or modified in any respect.

Changes relating to the Scheme

There have been no material changes to the Scheme during the Accounting Period. The following is a list of non-material changes made to the Product Disclosure Statements (PDS) and Other Material Information (OMI):

- PDS:
 - Capital New Perspective Fund and Clarity Global Shares Fund risk indicators changed from 5 to 6 in September 2022.
 - Clarity Capital New Perspective Fund management fee reduced from 1.25% to 1.15% in September 2022.
 - O Clarity Diversified Growth Fund Strategic Asset Allocation changed from 47.5%/47.5% Australasian/International Equities split to 37.5%/57.5% in September 2022.
 - o Clarity Fixed Income Fund risk indicator changed from 2 to 3 in March 2023.
- PDS & OMI: Clarity has implemented Swing Pricing triggered by a threshold to ensure any impacts on non-transacting investors from large transactions are borne by the transacting investors, and to manage significant market volatility.
- PDS: TAHITO Te Tai o Rehua obtained Responsible Investment Association of Australasia (RIAA) Certification, disclosures have been updated to reflect this.

No related party transactions were entered into during the Accounting Period that were not at arm's-length and enacted on normal commercial terms.
