# **CLARITY GLOBAL SHARES FUND**

## What is the purpose of this update?

This document tells you how the Clarity Global Shares Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Clarity Funds Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### **Description of this fund**

The Fund will provide actively managed exposure to international equities, and aims to generate a better return than the benchmark over the medium to long term. We use a global investment manager for this Fund, being MFS. MFS use a mix of fundamental and quantitative analysis to select companies.

## What are the risks of investing?

Risk indicator for the Clarity Global Shares Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



## How has the fund performed?

We calculate the market index annual return from 29 September 2023 by using the MSCI All Country World Index (net dividends reinvested) in NZ dollars with 50% hedged to NZ dollars. Between 3 April 2017 and 28 September 2023, the market index used was the MSCI All Country World ex-Tobacco Index (net dividends reinvested) in NZ dollars with 50% hedged to NZ dollars. This shows the return after fund charges and tax for each year ending 31 March since the fund started. The last bar shows the average annual return since the fund started up to 31 December 2024. ## What fees are investors charged?

## **Example of how this applies to an investor**


Small differences in fees and charges can have a big impact on your investments over the long term.

Chris had \$10,000 in the Clarity Global Shares Fund at the start of the year and did not make any further contributions. At the end of the year, Chris received a return after fund charges were deducted of \$2,729 (that is 27.29% of his initial \$10,000). Chris does not pay any other charges. This gives Chris a total return after tax of \$2,584 for the year.

#### What does the fund invest in?

The chart (below) shows the types of assets that the Clarity Global Shares Fund invests in.

As at 31 December 2024, 101.53% of the Fund's assets were denominated in foreign currency, but 49.32% of this foreign currency exposure was hedged.
