The name of the Scheme is Daintree Funds Scheme, comprising one retail Fund:

- Daintree Core Income PIE

The Scheme is a registered Managed Investment Scheme which is an "other" managed fund, that is, a managed fund that is not a KiwiSaver scheme, workplace savings scheme or superannuation scheme.

The Manager of the Scheme is Clarity Funds Management Limited (**Clarity**).
